- C) Treasurer- Leigh Atkins-Discussion of Insurance policy to cover Board of Directors, for BCIA. Can we get a representative to come and explain what it covers and what it excludes. It is a national company. Jessica will have her husband review the policy and its regulations. It needs to be addressed before 12/15/15. She will report back to the Board.
- 1. Financials- Budget Only one outstanding Invoice is from Halloween Party, for the DJ, BeetleJuice The check was for \$225. We paid the whole bill instead of the deposit. We overpaid, the agent will send the refund back to the neighborhood box. Leigh will check the box. Question from Larry Stanton, does Board pay for legal fees for variance questions. We are under Budget for legal fees. The person requesting the Variance has to absorb the legal fees. Gonzalez variance plan, it has been approved.
- 2. Banking- Leigh sent a separate Budget for the year, via e-mail. See Lee's email about taxes being paid on a cash basis. Leigh will meet with Charlie Stoddard about us not having tax liability, but we need to file. Last filing was 2012. Robbie suggested that we hire someone to handle our specific situation, due the audit, and clean it up. Leigh will talk to Michael Bancroft about how to go about cleaning this up. Problem with late fees with one homeowner, any errors they should be in favor of homeowner. Penalty and interest needs to be stopped when paid. Leigh- Accountant's Review, has not been done since 2012. We will have him do 2013-2015. Leigh will talk to him about filing taxes.
- D) Security- Chad Roberts- talked to Charnwood, we are trying to get the townhomes and Charnwood to go in together with a Security Patrol. We might be able to double our time of service if we can get the whole area

on the same system. Seal wants a 40 hour patrol each week but the expense is great. We will check into this. It would help if we could work with Charnwood and the Townhomes to support security for this whole area.
